



# Registration Form

Thank you for your interest in the **Clean Net Zero** Program! The goal of Clean Net Zero is to retrofit your home so it produces as much energy as it consumes (that's why we call it "net zero").

By registering, you are applying for financing for these deep energy retrofits. The financing will be provided by LaHave River Credit Union. If you live within the Town of Bridgewater you will also be eligible to combine LaHave River Credit Union financing with Property Assessed Clean Energy (PACE) financing through the Town.

## What's Next?

Upon receipt of your completed Registration Form, Clean will make sure you are eligible for the program. Your home's eligibility will be based on the following:

- You own your home;
- You have at least 20% equity in your home;
- The home is a detached, semi-detached, or row house style home (if a mobile home, it must be affixed to a foundation and you must own property);
- To be eligible for the PACE funding component of the program your house must be located within the Town of Bridgewater boundary;
- A review of municipal accounts (taxes, rates and charges including water bills) for all Town of Bridgewater properties to verify that they are currently in good standing, and that you have made consistent efforts to keep accounts paid for up to 5 years in the past.

**Please note that by registering you consent to the Town of Bridgewater and LaHave River Credit Union sharing the above information with Clean.**

After you qualify for Clean Net Zero, you will need to sign the Clean Net Zero Agreement. Once this is signed, Clean can help you book a certified Home Energy Assessment. Clean will also help you schedule an appointment with LaHave River Credit Union to arrange a financing agreement. LaHave River Credit Union may require additional information to assess your current home equity, your current debt load, and your creditworthiness.
